- 5. Tenders must be accompanied by a Health and Safety Policy, Workmen's Compensation, Valid NIS Compliance, Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue not more than Six (6) months prior to the closing of the tender. (Vat where applicable).
- 6. A list of the Owners of the Organization, a copy of the Company's Certificate of Registration, Notice of Directors/change of Notice of Directors <u>MUST</u> be submitted with your Tender.
- 7. All tenders **must** be fully priced including Item of Work, Material, Labour & Total Columns.
- 8. The form of Tender/Bill of Quantities must be placed in a sealed envelope and addressed to the Chief Executive Officer, Penal/Debe Regional Corporation.
